The Brooks family owned a number of buildings along the Belfast Road including a blacksmith shop, a wheelwright shop, and a store/hall where the Belfast Post Office was located. The Belfast school was built on land which was once a part of their holdings. In addition, the Brooks owned several large farms on the south side of Belfast Road.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The George Canoles House is a stone house, the principal part of which, facing south, is four bays in length, three storeys in height; a kitchen wing of coeval construction extends north, flush with the west end, two bays in length, two storeys in height with a shed roof perpendicular to the gable roof of the principal section to the front; its taller wall is its westerly. Single-flue flush chimneys of brick rise above each gable end and the kitchen chimney rises, in brick, flush with the northwest corner of the kitchen wing. A two storey frame addition, its roof an extension of the kitchen's, fills the northeast angle formed by the house and its kitchen wing; this addition may incorporate parts of a narrower porch with decks at each floor level.

The general three storey form of this house together with its many remaining original details reflect a late rural interpretation of the Greek-revival and the absence of fireplaces suggests a date hardly earlier than 1850-1865.

Each middle bay of the principal facade contains a door, sheltered by a one storey hipped roof porch with largish square columns; other bays contain 6/6 windows with narrow frames and louvred blinds; third storey windows are 3/3, also with louvred blinds. Windows in each storey flank the westerly chimney but the east wall is void of openings. Large stone lintels support the

masonry above the south front openings but wooden lintels with projecting end blocks support masonry above other windows. A recessed rectangular stone high in the gables immediately beneath each chimney suggests intended date and signature stones; on the easterly one is painted '1796' but no evidence suggests such early construction.

Internally, each south front door opens into an identical room; between them the stair rises to the upper floors straight and enclosed between the partitions. In the second storey a narrow hall subtracted from the westerly room allows access to the similar staircase to the third floor. The kitchen wing is a single room and an enclosed winding stair rises to the second floor in the northeast corner, adjacent to the chimney.

Architraves in the principal spaces are beaded with an echinus backband, raked at the top. Mantels, probably surrounding a stove-pipe hole, are applied to the flush wall at the chimneys; original ones include plain pilasters supporting a plain frieze. Doors are of four raised panels, those in the lower storey having loose mouldings.

In the cellar, which extends under the principal part of this house, the straight-sawn joists are exposed and no evidence is apparent of chimney foundations, the single-flue existing ones being original, within the thickness of the end walls.

Numerous small outbuildings remain including, among others, a wooden smokehouse, a wooden dairy and wash house, two wooden privys and a small stone barn, but two bays in length, set into the hillside northwest of the house, its upper storey having a framed section cantilevered over the lower storey to shelter a door in the easterly bay, a window in the westerly.

This modest dwelling with its stone outbuilding and frame blacksmith shop dates from the 1870's. It was built by Daniel Brooks and inherited by his widow and children. It is presumed that this was a tenant house and that the present George Canoles house (q.v.) was probably the family dwelling of Mrs. Sallie Brooks shown in the 1877 Hopkins Atlas. The 1896 Baltimore County tax shows that the Brooks family owned two stone dwellings, a log smith shop, stone stable, a wheelwright shop and a frame building described as a store with a hall, all at Belfast. In about 1860, about one half an acre of their land was sold to the county for the Belfast schoolhouse, which is still standing just west of this house.
