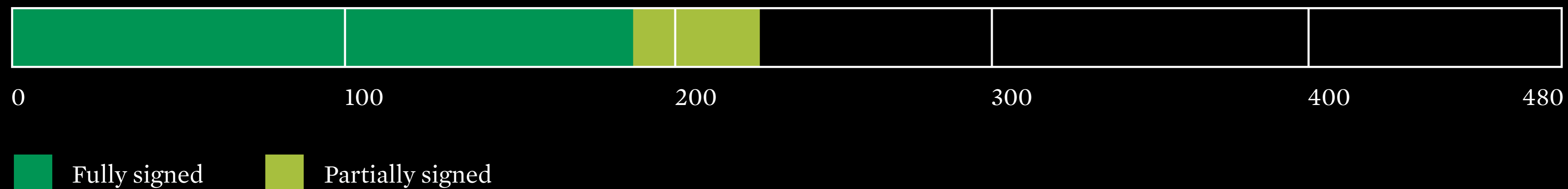

# Deed & Agreement

---

- 1913 Agreement must be renewed every 20 years
  - 60% of properties (480) and two-thirds of land area are required
- 187 properties fully signed—total of 800 properties, so 24.2% complete (38 other properties have at least one property owner signed)
- 28.4% (2,933,563 / 10,313,332 sq ft) of land area has signed the Agreement

- Vacation checks available for those who fully pay the GSP fees. Information on the Guilford website.

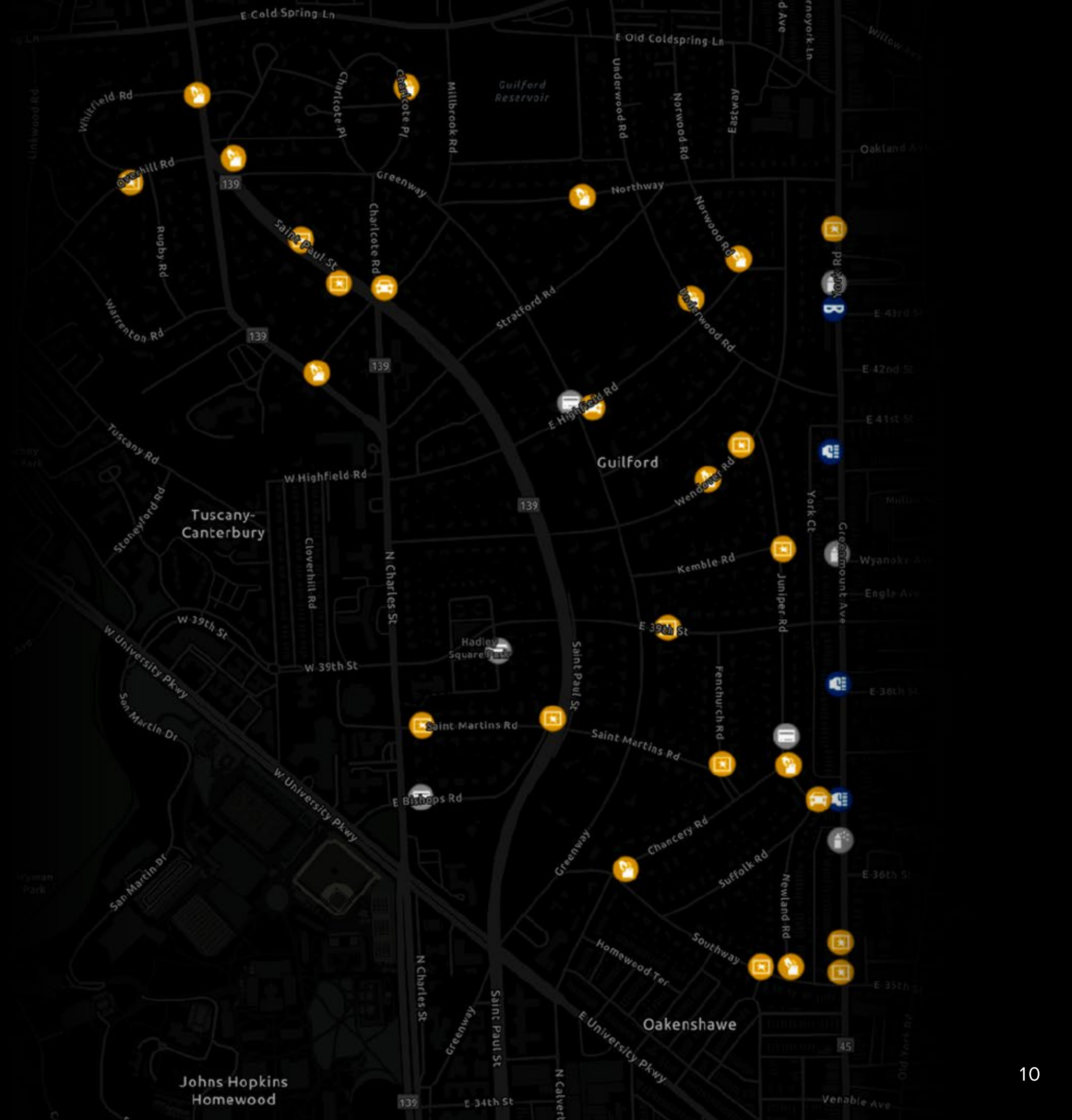
# Incidents of Crime

November 2024 – October 2025

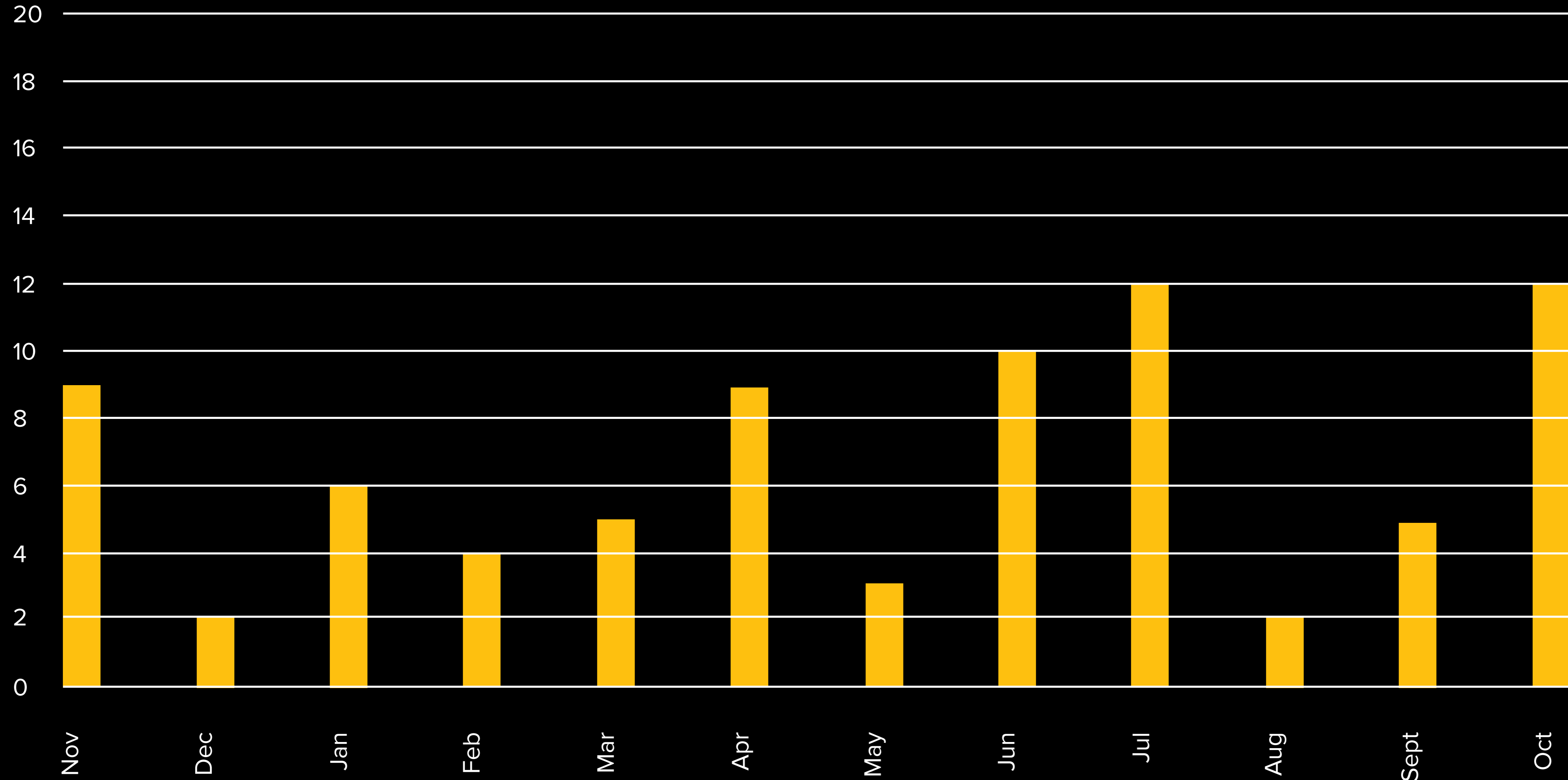
- 76 “crimes” within Guilford  
(Note: many “incidents” contain more than one “crime”)
- 84% of all crimes were property-related
- Total incidents were approximately 2/3 of those in Homeland (114) and Roland Park (115)

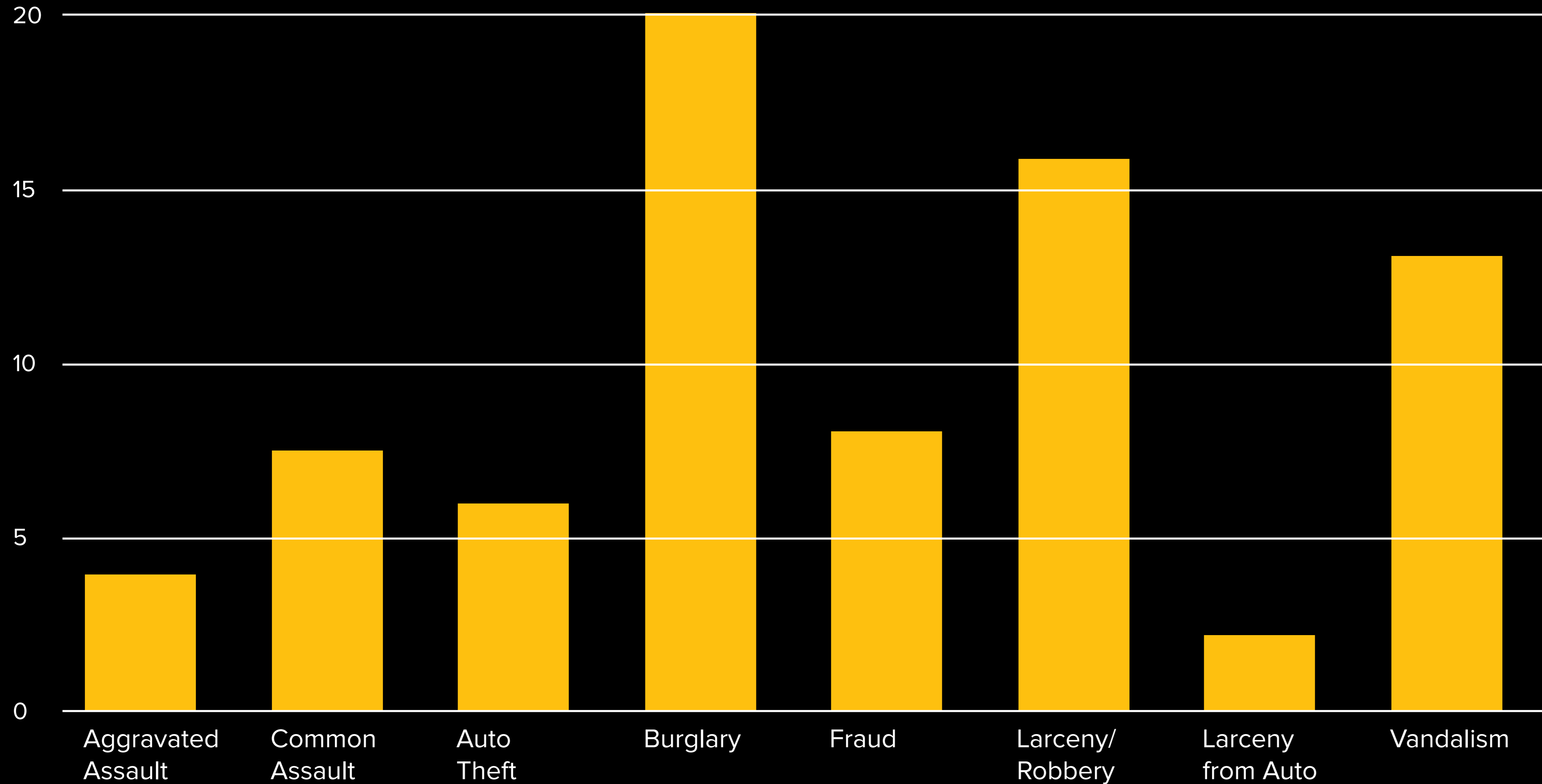
# Crime by Month

Nov 2024 – Oct 2025



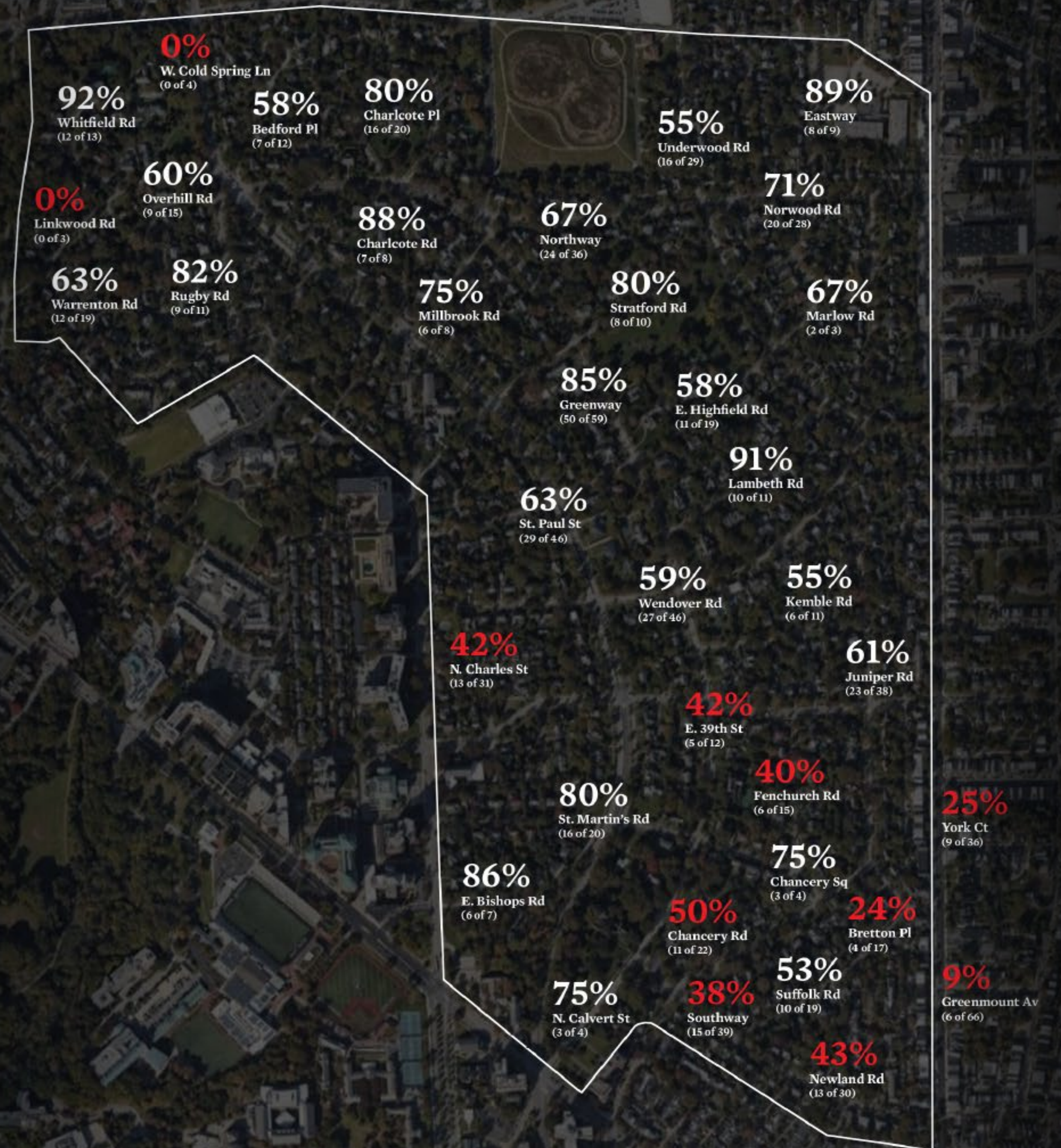
# Crime by Type

# GSP Contributions

- Approximately 53% of property owners contribute to the Guilford Security Patrol (GSP)
- Similar participation numbers in the past 3 years
- Contributions fund 75 hours of coverage each week
- \$63,000 budgeted to supplement contributions

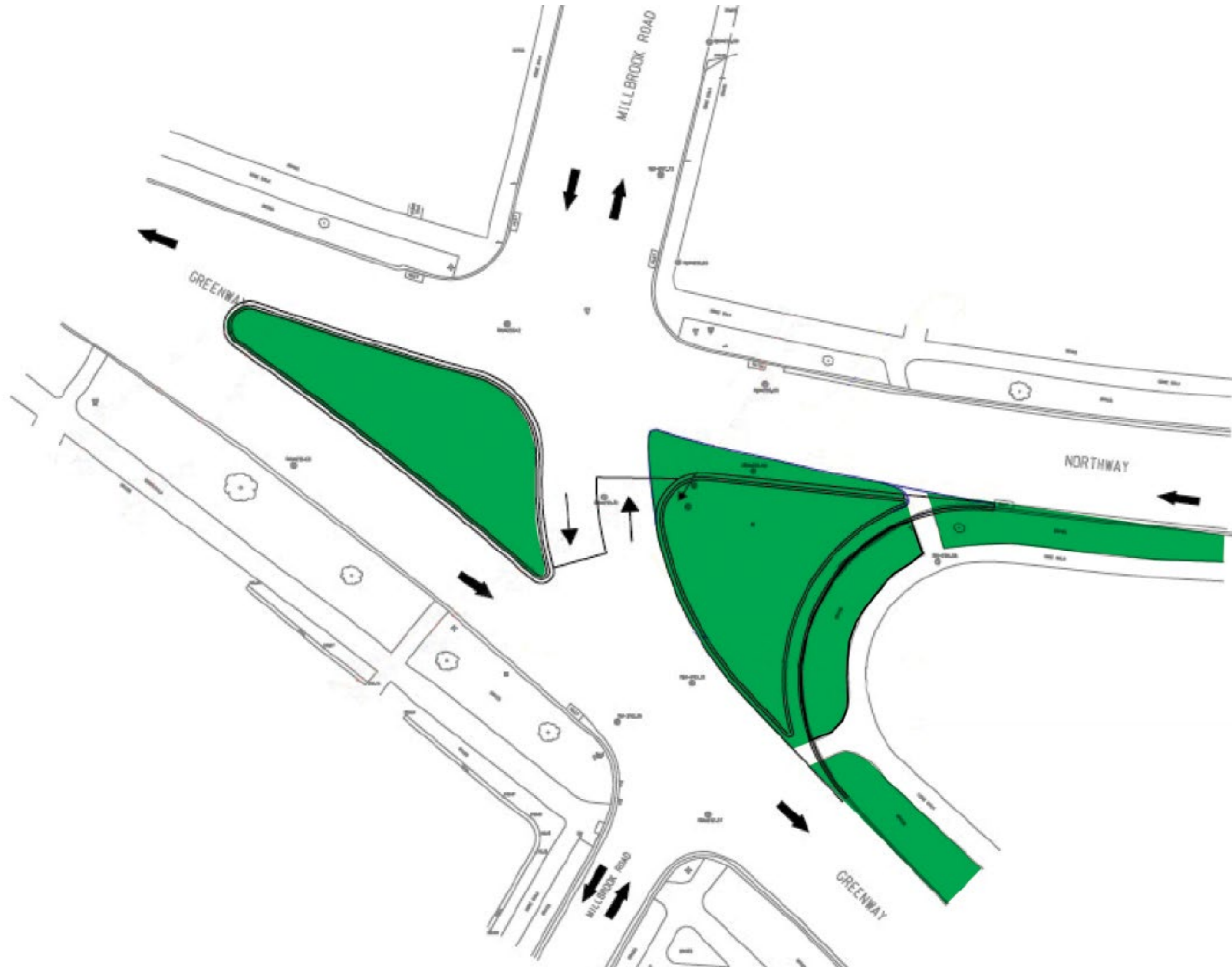
# Traffic & Streets Committee

- Norwood Road Utility Work  
Sewer main replacement project is underway.  
Sidewalks have been repaired.
- Loyola University Student Parking  
Received approval for an expansion of Residential Parking Permit Area 6 to include Millbrook Rd.

# Sidewalk Repairs

---

- Still on a backlogged waitlist of 7 to 9 years.
- Met with DOT recently about non-conforming material used in many repairs. Maintaining a list of sidewalk repairs needed.
- Residents are still free to contract for their own sidewalk repairs, but must keep in mind that sidewalk repairs **MUST** conform to the standard materials (exposed aggregate) used throughout Guilford.
- If the city repairs your sidewalk, you will be billed for the work unless it was caused by damage from a city-owned tree.



# Street Lights

---

- New lamps are being installed in the neighborhood.
- Many of the new street lamps have no glass/glazing and have LEDs that emit VERY bright white light.
- Meetings with DOT and BGE about ensuring standard lighting in the neighborhood. Discussions are ongoing.



# Parks Committee

---

*Emily Brennan*

- Four community parks — Sunken Park, Little Park, Gateway Park, and Stratford Green/Sherwood Gardens
- Maintenance of St. Paul Street Median, N. Charles Street bumpouts, Bedford and Chancery Squares, and multiple smaller spaces and “islands” throughout the neighborhood
- Nearly 14 acres of green space

# Architectural Committee

---

*Jeremy Hoffman*

- 83 formal Architectural Applications received to date. Anticipate over 100 by end of year. Most are approved or approved with comments and guidance.
- Committee reviews applications monthly with a licensed architect and an architectural historian, who are both non-Guilford residents.
- All proposed exterior changes are reviewed for consistency with the Architectural Guidelines. Reviews of exterior alterations are required by the Deed & Agreement.
- Hundreds of thousands of dollars were again invested in restoration and improvements this year, including a number of alterations where residents are planning to age in place.

# Home Sales

---

- 29 properties have sold in 2025 (to date) with an average sales price of \$886,134
- 31 properties sold in 2024 with an average sales price of \$938,081
- The Committee reviews all properties listed for sale for covenant compliance. Identified issues are either resolved by the seller or the buyer enters into a Correction Agreement with the Guilford Association.
- Missing shutters and unapproved fences remain the most common issues.



# York Rd/Greenmount Ave Committee

- Outreach efforts continuing south of E. 39th Street—seeking new committee members!

# Guilford Elementary & Middle School Reuse

---

- Property to be sold by the City
- Site is subject to terms of the Guilford Deed & Agreement
- Midtown Academy of Bolton Hill is pursuing the property as they need additional space for their students. K-8 charter school and has been serving Baltimore students since 1997.
- Discussions ongoing between Midtown Academy and Baltimore City Department of Housing & Community Development (DHCD); Guilford staying connected on timing of potential sale.
